**Investigator Insight:** Garage Sale Season is here! We want to give you a few prevention tips if you are hosting a garage sale.

- Keep all the doors to your home locked.
- We have seen counterfeit bills used at garage sales; study the currency before accepting it. Don't take checks.
- Keep your cash/change with you in a money belt or fanny pack – or have a person assigned to attend the cash box at all times.
- Watch for people trying to use "distraction" techniques – don't fall for them.
- Keep your advertising signs out of the roadways right-of-ways.
