# **Presidential Nomination Primary**

Election Day: Tuesday, March 5 Polls Open from 7:00 am - 8:00 pm

#### What is the Presidential Nomination Election?

- Legislation was passed in 2016 to establish a presidential nomination primary to award delegates as part of each major political party's presidential nomination process.
- Only major political parties are eligible to participate in the presidential primary. Each party will have a separate ballot. The voters must indicate which party's ballot they wish to receive and sign an oath affirming: "I am in general agreement with the principles of the party for whose candidate I intend to vote."
- Your party selection is considered private data.
   However, each voter's party selection is recorded and shared with the chairs of each major political party.
- Precinct caucuses will still be held on February 27, 2024 to develop positions to shape the party platform.




# **Approval of the 2024 Budget**

On December 4th, 2023, the City Council approved the 2024 Budget. The General Fund budget is primarily funded by the property tax levy of \$6,274,218. When including other revenue sources, the total revenues for the General Fund are \$7,228,953. This is an increase of \$287,585 when compared to the 2023 budget. Total expenditures are \$7,307,340, an increase of \$365,972 from the 2023 budget.

#### **How Does the Levy Impact Property Taxes?**

The City saw an increase to its levy of 4.38%. However, the City also saw an increase of \$2,692,627 or 8.79% to its net tax capacity. This increase in net tax capacity helps to offset any impact of the levy increase causing the tax capacity rate to decrease from 19.50% in 2023 to 18.86% in 2024. The chart below shows how the decrease would affect the City portion of your property taxes if the value of your home remained constant and the actual affects when taking into account increases in market values:

# Obey Ham Lake's Snow Rules

Respect your neighbors by following the City's policy on parking and on where to deposit snow and ice. Minnesota law makes it illegal for property owners to deposit snow or ice on any street or highway. This includes the 15-foot right-of-way back from the curb. Therefore, it is illegal to plow snow from your driveway and move it across the street onto the right-of-way of the property across from you.

# Ham Laker's Winter Parking Rules

Remember, from October 1 through April 30 "NO PARKING" is allowed on Ham Lake streets between the hours of midnight and 6:00 am.

In addition, no parking is allowed in the daytime hours during or after a two-inch snowstorm or until the streets are plowed afterwards.

### Winter: Best Time to Prune

Winter is the best time to prune your trees for the following reasons:

- The absence of leaves makes crossing branches and weak spots easily seen.
- The risk of spreading disease via pruning cuts is minimized. Insects that carry oak wilt from infected trees to fresh pruning cuts during the spring and summer are not present during the winter.
- Equipment can be moved closer to trees on frozen ground when lawn damage is not a great concern.
- Growth is increased since the energy stored in fewer roots and branches is channeled to fewer points the following spring.

Required documents need to be picked up at the Ham Lake Senior Center and filled out before coming to your appointment. Collect all your tax documents, including your prior year's tax return, and bring all of it to your appointment. Please arrive on time (or 15 minutes early).

## **December Building Permits**

The City of Ham Lake issued 73 permits in December with a valuation of \$412,131.23.

## Ham Lake Fire Department's Carbon Monoxide Safety

Carbon monoxide (CO) is an invisible, odorless gas that is produced when burning any fuel such as gasoline, propane, natural gas, oil, wood and charcoal. CO is a silent killer, causing illness by decreasing the amount of oxygen present in a person's body.

Young children are especially vulnerable to the effects of CO and may show symptoms sooner than a healthy adult. Because of their smaller bodies, children process CO differently than adults and may be more severely affected by it.

#### **Physical Signs of Exposure**

Mild exposure: **Medium exposure:** Severe exposure: Slight headache **Drowsiness** Convulsions Vomiting Confusion Unconsciousness Nausea Severe headache Cardiac/respiratory arrest **Fatigue** Rapid heart rate Even death

Flu-like symptoms that disappear when the person breaths fresh air

CO poisoning can often be mistaken for other illnesses, such as the flu. Often, more than one person in the household will suffer symptoms at the same time.

#### **Protect Yourself**

Blurred Vision

- Install a CO alarm outside every sleeping area.
- Place CO alarms at least 15 feet away from every fuel-burning appliance to reduce the number of nuisance alarms.
- Test alarms every month and replace them every five years.
- Have all gas, oil or coal burning appliances inspected by a technician every year to ensure they are working correctly and are properly ventilated.
- Never leave a vehicle or other combustion engine running inside a garage, even if the door is open.

#### If Your CO Alarm Goes Off

- Investigate to make sure it is your CO detector and not your smoke detector. Check to see if any member of the household is experiencing symptoms of poisoning.
- If they are, get everyone out of the house as quickly as possible, then call 9-1-1 from a cell phone or a neighbor's home.
- If no one is feeling symptoms, ventilate the home with fresh air; turn off potential sources of CO. Appliances and other devices which could produce CO should be checked to make sure they are operating correctly.

- Choose your tax preparer carefully.
- Double check that your incoming mail is secure.
- Follow-up if you don't receive expected paperwork.
- Don't believe just anyone who says they're from the IRS.
- Dispose of your paperwork carefully by shredding.
- If filing online, make sure your antivirus software is updated.
- · If you are mailing your returns, mail it from a secure US Postal box.

# Ham Lake Business Spotlight: Sinn City Fitness

Sinn City Fitness is Ham Lake's newest gym. Established in August 2023, founder and owner Gaile Sinn took over the Warehouse Fitness space and has since redesigned and converted it to reflect her own vision and goals.

Gaile has dreamt of owning her own gym since she was 20 years old. Her path took her through college, a Master's Degree and then the corporate world. Eventually, she knew she wanted to be directly involved with helping people and started to work for gyms in the Blaine and Ham Lake area. This helped

her grow her experience enough to see her dream become reality a few months ago.

"It's been an exciting adventure," she said. "I still can't believe this is my gym when I walk in here some days!" Hearing the members' stories—like I'm in the best shape since high school—spurs her on to put in the work needed for success.

She also knows the power of being physically healthy when going through tough experiences.
