Scams

03.20 Snapchat Blackmail Scam: Victim texted 911 saying he needed help. Upon arrival, he told deputies that he was added by a Snapchat account "macyy_jenkins" that sent him a booty pic. He sent back pictures of his genitals. He does not know who the account user is. The account told him they are 13 years old and that he needed to send them money. He was told this is a common scam and to not send money. Records show he had been involved in a similar incident in January, 2022 in Isanti County.

Andover

03.21 Quinn/Bunker Lake Blvd NW – We had a vehicle flee from deputies. The car was dumped. The SWAT team and K9's cleared the vehicle which was empty. A search for suspects, and thrown items, was conducted. A duffle with meth and other items was located. The suspect is identified and we will continue to try to locate him.

03.18 151xx Bluebird St NW – catalytic converter was cut off vehicle parked in lot overnight 03.19 137xx Vale St NW – resident confronted a male putting trash in his bin and the male took out the trash bags and through them in the ditch

 $03.20\ 150xx$ Yellow Pine Ct NW – three juveniles throwing fire works and playing ding-dong-ditch were caught and returned to their parents

03.22 13xx 144 Ave NW – theft from unlocked vehicle; tools, cash, lighters

Arrests

03.18 Martin/Bunker Lake Blvd NW – DWI 4th degree; a deputy stopped a driver for erratic driving. When he made contact, he could smell alcohol. When asked she stated she had a couple drinks. Field sobriety tests were conducted and failed. She was arrested. .08

03.18 Andover Blvd/Prairie Rd NW - DWI Refusal; a deputy stopped a driver for poor driving conduct. When he made contact, the male appeared impaired and asked if he could just go home. The driver refused to do field sobriety tests or PBT. He was arrested. The male began hyperventilating and an ambulance was called. Paramedics cleared him and he went to jail.

03.18 13xx 139 Ave NW – DWI, Domestic Assault; a caller reported her husband was threatening to kill her. When rolling up on the scene, the husband was seen trying to leave in a vehicle and he was stopped. He pulled back into the driveway and exited the vehicle. When talking with deputies they could smell alcohol. He refused to cooperate with the field sobriety tests and was arrested. .017

03.18 13xx 153 Lane N W- Domestic Assault; deputies were dispatched to a physical domestic between a husband/wife. After investigating, the husband was arrested.

03.18 18xx Bunker Lake Blvd NW – Shoplifting, Warrant; deputies went to the location to speak with a shoplifter. When she was identified, it was found she had a warrant for drugs. She was arrested.

03.18 7 Ave/Bunker Lake Blvd NW – Drugs, Warrant; a deputy stopped a vehicle for having expired tabs (2021). When he made contact, he could smell marijuana. When the driver was identified he did not have a driver's license but did have a warrant out of St. Louis County. He was arrested. The vehicle was searched prior to towing and multiple sealed bags of marijuana was found along with some Oxy.

03.19 Bunker Lake/Hanson Blvd NW – DWI Refusal; a deputy ran a plate and the registered owner came back as canceled inimical to public safety. He stopped the driver. When speaking with her she smelled like alcohol but said she just dropped a friend off who had been drinking. She did not have a license. When asked if she had been drinking she stated no but she appeared impaired. She refused to do field sobriety tests but agreed to PBT. She blew .15 and was arrested.

03.19 18xx Andover Blvd NW – Warrant Arrest; a deputy observed a male outside and he knew he had a warrant. The male saw the deputy and ran. He was located and arrested.

03.19 139xx Underclift St NW – Warrant Arrest; a deputy learned a female with a warrant was staying at the location. He went and was let in by the homeowner and the female was arrested.

Arrests

03.18 23900 Block University Ave – DWI 4th degree; a deputy ran a plate and it came back expired as of 09/22. He stopped the driver. When he made contact, the driver appeared impaired and stated he had just left a bar and was driving his friend home. Field sobriety tests were conducted and failed. He was arrested. .125

Arrests

03.20 Lake Dr/Potomac St NE – Warrant Arrest; a deputy ran a plate and the registered owner came back with a felony warrant out of Chisago County. He stopped the vehicle, the woman was identified, and arrested.

03.22 Lake Dr/Zurich St NE – Obstructing Legal Process, Warrants; a deputy ran a plate and the registered owner came back with multiple warrants. He followed her into a parking lot and made contact. She claimed she was getting the warrants taking care of "tomorrow" and refused to exit the vehicle. She called 911 and told dispatch the deputies were sexually assaulting her and that they killed someone. Three other officers needed to come to assist and she was finally removed from the vehicle and arrested.

03.23 232xx University Ave NE – a vehicle stolen out of Blaine was located at the location

Arrests

 $03.19\,$ Hwy $65/229\,$ Ave NE - DWI 3^{rd} degree; deputies were on scene due to a vehicle being in the ditch. When a deputy was talking to a witness, he stated he was following the driver in the ditch

home to make sure he was safe because they had been drinking out at a bar. The witness appeared impaired and field sobriety tests were conducted and failed. He was arrested. .181

03.23 Viking/East Bethel Blvd NE – DWI 2^{nd} degree; a caller reported a possible drunk driver. He located the vehicle and stopped it for erratic driving behavior. When the deputy made contact, the driver lit a cigarette and stated he was going to the store to buy more smokes. He appeared impaired and was slurring his works. Field sobriety tests were conducted and failed. He was arrested. .241

Arrests

When he made contact, there was a male under a blanket in the back seat supposedly sleeping. The driver, a female, has been involved in criminal activity recently and when asked who was in the back seat, she said it was her husband. After investigating it was discovered they both lied about the male's identity and he had a two felony warrants. An IBIS machine was brought to the location to confirm the male's identity. He was arrested.

The driver stated he didn't have his license with him and then gave a false name to the deputy. After investigating the driver was found to have no license and a felony warrant from Isanti County. He was arrested.
