Scams

04.28 The caller reported his father had fallen victim to a theft by swindle of at least \$49,000 by wire fraud. The suspect had called the victim and convinced him to reset his online password and tricking him into sending the passcode that was texted to him by Wells Fargo. The suspect was able to complete a wire transfer under the guise of an investment. The suspect also used a spoofed phone number that matched Wells Fargo. The suspect then had the victim go in person to the Wells Fargo branch and complete another \$49,000 wire transfer under the guise that he was assisting undercover police who were trying to catch a teller stealing from the bank. This second transaction was cancelled because it was deemed suspicious by Wells Fargo.

05.02 The victim said Microsoft was working on his computer and he had given them control. I looked closer and could see whoever was controlling the computer remotely appeared to be opening files. I then shut the computer down in an attempt to prevent it from being accessed further. The victim was never able to fully explain how the party on the phone had gotten his number to make contact with him or how they had accessed his computer, but he was able to tell me that this started when he was trying to access a new gmail account he had recently created. It is believed based on the conversation with the victim that the party on the phone likely accessed his information and computer through a scam email link. He informed me that the party on the phone instructed him to withdraw \$40,000 from his bank and deposit it into some sort of federal bank. He said the male also told him not to bring his phone when he was completing the deposit. The victim sent his wife to the bank to make the withdrawal. Her phone was sitting on the computer desk and I was unable to make contact with her. A short time into my conversation with the victim, his wife returned home informing me she had gone to the bank but did not withdraw money because the bank informed her she was being scammed.

04.27 138xxx Round Lake Blvd NW – business; used a fire extinguisher to break window, sunglasses

Field sobriety tests were failed and she blew a .05. She was arrested. Marijuana was also located in the vehicle.

05.01 Crosstown/Bunker Lake Blvd NW – DWI Refusal; a deputy was called to a property damage crash; one vehicle rear-ended another stopped at a light. The driver of the vehicle that rear-ended the other appeared impaired and stated she had a couple drinks earlier. Field sobriety tests were failed and she PBT'd .30. Open alcohol shooters were found in her purse. She was arrested.
