Scams

05.25 Home Repair Scam: The victim wrote a check for \$3,300 to a male to complete remodel work on the bathroom and deck. She called today because she has been unable to get ahold of the male since 05/23/2023. The victim began doing online research of the contractor and found many Yelp reviews of him taking customer's money and never completing the agreed upon work. She has copies of the agreed upon work and pricing for the two projects. I used Vinelink and discovered the contractor was currently in-custody at the Hennepin County jail for one charge of theft and one charge of theft by swindle, with a booking date of 05/23/2023 at 1703 hours. I advised her that he wasn't ignoring her, he was in jail and couldn't answer his phone. Given the nature of his charges, and past reviews on him from Yelp, I advised her that criminal charges could arise from this, just not yet as James has not had a chance to complete the work. She inquired if she could just get her money back and not let him return to the house. I advised her that would be a civil issue that they would have to work out themselves or in civil court.
