Scams

07.06 The victim stated on 07/01/2023 while on Facebook Market Place she received a message on her computer to notify her she was being hacked and to call a number to prevent further damage. She contacted an unknown person, and they wanted sensitive information from her. She then became suspicious and hung up the phone. She did not lose any money.

07.06 The victim said he posted a hay bailer for sale on FB Marketplace on 6/30/2023. A male purchased the item and sent him a check via USPS for \$2000; the asking price was \$1000. The buyer said the extra \$1000 was to pay the person who was going to pick up the equipment for shipping. He told him to deposit the check. He did and the check cleared the bank. The buyer requested him to send the extra \$1000 via Venmo or Apple pay to the shipping company. He said he did not do electronic of app payments and would have cash for the driver when he shows up. There has been no other contact with the buyer since them. I advised him not to send or give anyone the money as the check can still be voided and to work with the bank. I also advised him to call 911 if anyone shows up.

The male was arrested.
