#### **Scams**

12.21 The victim reported that she was on her computer and she received a pop-up message that told her to call 855-777-3929, because her computer had been compromised. She called and spoke to two separate people. One of the people went by the name "Alison". The victim was convinced to purchase \$5000 worth of gift cards and then provide the card information to the people on the phone. She advised they were communicating through "Any Desk" on the computer. Microsoft was contacted and advised it was not them, and that it was fraud.

12.28 The victim stated she had \$473,000 stolen. She was closing on a house in Coon Rapids and the relator she was working with had an email of XXX in which they were communicating through. She received and email from an address very similar, but not the same, however she did not notice right away. She explained that the person using the fake email was informing her how to wire the money and gave her the information over email. The money was sent and when she called her realtor, they informed her they had never received the payment. She contacted her bank to stop the payment and to report it as fraud. The payment is currently being held, and she was informed she needs to have her bank call them to return the money. She did not trust the credit union, and I verified with a representative over the phone this was legit. They informed me that someone who banks through them was the person who initiated the transaction to receive the victim's money and they are investigating.
