FRIDAY UPDATE: 05.28.21

It only takes a second. Remember to never leave your vehicle unlocked with the keys in it:

On 05/27/21 at approximately 2335 hours, I was dispatched to the location on a report of a stolen vehicle. Upon my arrival I made contact with the victim. She stated she had been leaving work at approximately 2230 hours. Once to her car, she remembered that she had left her work computer inside. She shut her vehicle off, left the keys in the ignition and went back into her office for the computer. The victim stated that when she came back outside, as she approached the vehicle it had started. She looked up and observed a person sitting in her driver's seat in what appeared to be a white t-shirt. She stated the vehicle reversed slightly and then peeled out of the area. The victim stated she had only seen a white t-shirt and what appeared to be "white spikey hair."

I entered the vehicle as stolen through channel three with the description provided. NFAT. Clear.

Scams

05.21 A female in San Diego was a victim of a scam where she provided Target gift cards to thieves to protect her Apple account. Two of the cards she provided were redeemed in Andover.

05.25 Call from "Social Security" claiming fraudulent activity on the victim's account requesting him to verify his SS number.

05.26 Call, Grandparent scam claiming to need \$23K for bail because her grandson was in trouble with the law. The victim was smart and called her grandson first and he was fine.

05.26 Call from 425.616.0381 claiming victim won the Washington State Lottery; one million and a vehicle. Claimed vehicle tax needed to be paid. No financial loss.

05.27 Call, Grandparent scam claiming to need \$8500 for bail; no financial loss.

05.22 141xx Drake St NW – an enclosed trailer parked at the location was stolen

Field sobriety tests were conducted and failed. A warrant for blood was obtained and he was arrested.

05.27 21xx 134 Ave NW – OFP Violation; deputies responded to a physical domestic at the location. When they arrived, they learned the female had an order for protection against the male. He was arrested.
