### **Scams**

01.04 Business: The victim stated at 0600 towards the end of her night shift she received a phone call from who she thought was the owner of the business. She stated the male was telling her to get money from the back room due to an issue with a FedEx package issue. The victim stated that the male asked for \$3,500 dollars for a time sensitive issue with FedEx. She stated the male sounded convincing and at first asked for a company credit card which she didn't have. She stated the male then asked about cash that she could grab, so she got the key and went in the back room where there was only \$655 dollars in cash that she grabbed. The victim stated she also gave \$75 dollars of her own money thinking she was helping. She then proceeded to a gas station in Blaine and deposited the money into a bitcoin machine and sent it to BTC #0.03404129 and a BTC address 37y1L26ekBa for the \$730 dollar price. She got a confirmation and tracking number and provided that to the scammer. The victim stated it happened so fast and didn't think it was a scam until the money was already sent and she was back at work.

01.05 Victim said that she was online on Careerbuilder and she thinks that she is possibly being scammed. She said that a guy by the name of Michael Gay who owns Olympic Controls INC is offering her a job. She said that all communication has been through text and is scripted. She said that he even sent her a photo of a check for over \$4,000 for her to cash and set up a home office. She said that she has never provided her full name and DOB or any other personal information. I told her to not provide any information as this is most likely too good to be true. She said that she would do some more digging on this guy and company, but she said she already can't find the company online. I told her that is a pretty good clue that it's not real.

When the male got her back to her vehicle, deputies were on scene. The female appeared impaired. Field Sobriety tests were conducted and failed. She was arrested. While searching the vehicle, a male was found in the trunk hiding from deputies. He had no warrants and was released.

01.02 Woodbine/138 Lane NW – Obstructing Legal Process with Force; a deputy ran a plate and the driver came back as revoked. He stopped the driver who said her license wasn't with her and lied about her name. When the deputy found out, he went to arrest her and she began to fight. During the fight, she went limp. Deputies called ambulance and it turned out she had low blood sugar. Paramedics fixed her up and she was taken to jail.

01.03 16200 Block Hanson Blvd NW – Drugs; a deputy stopped a driver for speeding 68/55. The driver pulled into a gas station and when he made contact with the deputy, his pupils were small, he appeared nervous, and had a small torch style lighter. Field sobriety tests were failed and a K9 was called to sniff the vehicle. A bunch of cocaine was located. A warrant for blood was obtained and the male was arrested.
