01.03 900 Block Crosstown Blvd NW – DUI; a deputy stopped a driver for having a headlight out. When she made contact with the driver, she could smell marijuana. She asked him if he had smoked recently, he said yes and that there was marijuana in the vehicle. A warrant for his blood was obtained and the male was arrested.

The driver was identified; her license was revoked and she also appeared impaired. Field sobriety tests were failed. Prior to towing her vehicle, it was searched; marijuana and a grinder were located. She was arrested. .09

01.06 16xx 155 Ave NW – Disorderly Conduct; deputies were called by a probation officer due to a domestic occurring between a mother and a daughter. They arrive, de-escalated the situation, and the daughter was arrested.

01.07 2xxx Bunker Lake Blvd NW – Shoplifting; deputies were called to two in-progress shoplifting suspects. They were able to get into position and greet the thieves as they pushed two carts, with over \$900 worth of goods, out of the store without paying. They were both arrested.
