### **Scam**

On 01.10.22 at 1417 hours I was dispatched a phone call report regarding a money scam. Upon calling, I spoke with the reporting party who advised that she had received a phone call from an individual identifying himself as Joseph Conzar from phone number: 312-690-9963. She advised that this individual was stating her son was in jail and needed to be bailed out. He asked her to obtain two separate manila envelopes and split \$9500 between the two and mail them to him to bail out her son. I advised her that this was a scam as bail is not handled in this manner. I advised her to not mail any money. I also advised her to block the number.

On 01-12-22 at 1229 hours, I was dispatched a suspicious phone call report. The reporting party reported receiving a suspicious voicemail from 763-712-8234. The male caller indicated he was from the "Legal Department" and requested a call back. I explained how these common phishing scams work and advised him to not return the call. Nothing further.
