SCAM ALERT from the Anoka County Attorney's Office:

Several Anoka County residents have been targeted by a new scam that uses tax lien data in fraudulent mailings. Scammers are combining public IRS lien data and using it to create official-looking letters claiming the recipient needs to pay back taxes within 15 days to avoid further action. The mailing looks official, is titled "Tax Processing Unit," and references the Anoka County Public Judgment Records. It includes an 800 number to call. This is NOT an official mailing, and does not come from Anoka County, the Minnesota Department of Revenue, or the IRS. If you receive this letter, DO NOT call the number on the mailing. Do not give out any private data such as Social Security Numbers or bank account details.

To inquire about any tax liens, call the Department of Revenue at 651-556-3000.

If you called the scammers and paid them money, call local law enforcement to report it.

Sheriff James Stuart would like to remind everyone that you should always verify suspicious contacts by researching the real phone numbers and making direct contact without using any phone numbers provided by the suspicious contact. Sadly, there are many sources of evil who wish to victimize you.
