FRIDAY UPDATE: 02.05.21

This is the time of year we see thefts from mailboxes increase due to the tax season, and this year, due to stimulus checks. The US Postal Service offers a program called Informed Delivery. This program won't prevent mail theft, but at least it will inform you of what pieces of mail should be in your mailbox that day. That way, if it isn't there, you know what preventative measures you need to take, or who you need to contact. I would recommend signing up. I think as humans, we need to do better. This behavior is crazy and unacceptable.

01.31.21 I was dispatched to the location on a report of a suspicious vehicle following the caller and screaming at her. Upon arrival, I observed her vehicle stuck in the snowbank on Fox St NW. I made contact with the lone female and identified her. She advised me that she had just left her friend's home in the area and was trying to find her way out of the development. She stated that she was driving on Fox St NW and a white Cadillac Escalade was honking the horn. She stated that she then honked her horn and the driver got aggressive. She said that she attempted to turn around and got stuck in the snowbank. She said that the Escalade pulled up next to her and the driver yelled "get the **** out of our neighborhood" then drove off. She said that she was too shaken up to drive so she made arrangements to stay at her friend's home. Deputies pushed her vehicle out of the snowbank and she followed me to her friend's home nearby.

If it isn't bad enough that you lost your dog, now scammers are taking advantage of your tragedy.

On 02-01-21 at 1042 hours, I was dispatched a phone call fraud report. The victim stated that her dog went missing yesterday so she posted the information on LostdogsMN.com. She received a text message from 812-270-9239 stating that they had found her dog. The sender asked that she send him a verification code so he could return her dog. She then received a six-digit code from a Google Voice account and sent him the digits; she never heard back. In researching the incident, the victim discovered this is a scam where the suspect is attempting to get into her Google Documents account. The code was more than likely for a password reset which would give him access to private information including financial accounts. The victim has already contacted her bank and applied for a fraud alert with the major credit companies. She was advised to watch her accounts closely and call back if any unauthorized activity occurs.

The deputies arrived and waited for the male to exit. Prior to exiting, he dumped all the merchandise into a cart. He was searched and the knife and other tools used to remove security tags were located on him. Along with the security video, there was enough evidence to charge him. He was arrested.
