FRIDAY UPDATE: 02.12.21

Here is a scam we have seen become more popular – *Wrap Advertising* on your vehicle:

On 02-08-21 at 1259 hours, I was dispatched to the Anoka County Sheriff's Office for a fraud report. Upon arrival, I spoke with the victim who reported a fraud attempt by mail.

He stated that several days ago he entered his name, address and phone number into a website for advertising on his vehicle. He then received an envelope in the mail from a company called "KC Steak Company." A letter inside the envelope gave instructions on how to receive the "advertising wrap" for his vehicle and payment information. Also inside the envelope was a cashier's check addressed to him for \$2600.50. The instructions stated he should cash the check, keep \$600.00, and use the rest for installation later.

The victim was suspicious of the letter and did not attempt to cash the check. I explained to him how this particular phishing scam works. He was also instructed to not communicate with anyone if he starts receiving phone calls regarding this incident. The letter and check were disposed of at ACSO. No monetary loss. Clear.
