FRIDAY UPDATE: 03.12.21

This wasn't a scam, but it is going to be a headache to fix. It appears someone is putting fake MN license plates on vehicles in California.

On 03-05-21 at 0829 hours, I was dispatched to the Sheriff's Office regarding a possible fraud report. The victim reported receiving a letter from the San Diego Police Departments a few days ago. The letter indicated his vehicle was involved in a hit and run property damage accident and requested insurance information. The letter listed his correct license plate but gave the vehicle description as a Hyundai; the victim's vehicle is a 2018 Dodge Charger. The victim stated he has never been to California and I confirmed he is not missing either plate on his vehicle. His concern is the letter may be fraudulent.

I made contact with the Records Division of the San Diego Police and confirmed the letter was legitimate. I also obtained the email address for the Detective assigned to the accident and advised the victim to contact him.

Here is a new one. An alarm was going off on a computer with a request to call Microsoft.

The victim stated she had a loud alarm go off on her computer yesterday around 8 am. She stated she looked at the computer and it showed a message from Microsoft to call 1-844-328-1515. The victim stated she could not navigate out of the message and called the number. She said she made contact with someone and allowed them to remotely access her computer through Zaho Assist. She said the person looked through her computer for about 45 minutes going through her browsing history. She stated the person wanted her to open her bank accounts and that is when she turned off her computer and told the person she was done.

Arrests

Once the male was woken up, field sobriety tests were conducted and failed. A warrant for blood was obtained and he was taken to the hospital. He will be charged by formal complaint.

03.08 13600 Block Round Lake Blvd NW – Drugs; a deputy stopped a driver for speeding. When the deputy turned on his lights, a call came out about a male with a gun inside a vehicle near-by. The deputy diverted to that call, went to the location where the male was supposed to be, but no one was there. The deputy turned around and located the original vehicle he had attempted to stop. He

located it and stopped it. The driver appeared under the influence of drugs. While speaking with the female, a male showed up near the scene screaming at deputies that he was recording the interaction and that "she" did nothing wrong and they were arresting the female illegally. Through investigation, meth, needles, and a brown liquid was found in the vehicle and the female was arrested. Another deputy went to make contact with the male screaming at them. It turned out he was the suspect's boyfriend and he had placed the fake 911 call to divert deputies. He was arrested too.

03.08 162xx Tulip St NE – Attempt to Locate Request; Cambridge PD requested a deputy to check the location for a male that had a probable cause pick up for a felony. The deputy went to the location and located the male. He was arrested.

03.10 20xx Bunker Lake Blvd NW – Shoplifting; deputies responded to a call of a shoplifter leaving the store with over \$1500 worth of merchandise. The suspect had stolen from the store before and the store identified him. When he stepped outside, he was given a trespass notice and arrested.

03.08 Hwy 65/237 Ave NE – Warrant Arrest; a deputy stopped a vehicle for having inoperable brake lights. When the driver was identified, it was discovered she had a warrant. She was arrested. When asking the passenger about driving the vehicle home from the scene, it was discovered there was not insurance on it and he did not have a driver's license. The deputies then ordered a tow. While searching the vehicle prior to towing it, drugs were found - and they belonged to the passenger, so he was arrested too.

03.10 204xx Hwy 65 NE – Drugs; a deputy responded to a call of a suspicious vehicle. She located the vehicle and made contact with the two occupants. While speaking with them, drugs were located. The driver was arrested, and the vehicle was towed.
