**FRIDAY UPDATE: 03.19.21** 

The world is not okay right now, there is something seriously wrong with humanity. I never though I would need to remind adults that they shouldn't take something that isn't theirs – yet, here we are:

Dispatched to a business for a theft report. Upon arrival I spoke with the manager who stated that someone stole a 2 wheeled dolly from near a gas pump. He showed me the video footage of the incident and I was able to get a plate off the vehicle. I went to the registered owners address and asked him to bring the dolly back. I advised if he did so, the store would not charge him with theft. I followed him back to the store and he returned the dolly without further incident.

#### **SCAMS**

- 03.12 Call claiming to be Social Security to advise victim there is suspicious activity on her account
- 03.12 Call claiming to be Social Security to advise victim there is suspicious activity on her account
- 03.12 Fake Craigslist add for free grout; victim went to pick it up and address didn't exist (Columbus)
- 03.15 Checks that were stolen from a vehicle in December are being used
- 03.16 Amazon scam, let thief install Ultraview on her computer and gain access
- 03.16 Social Security scam, phone call threatening an arrest warrant, requested personal info
- 03.18 Social Security scam, phone call saying vehicle with blood and drugs inside it was located
- 03.19 Scam, phone call demanding a guick call back or the caller was going forward with a lawsuit
- 03.18 Craigslist scam; sent fake check for over the amount of purchase and wanted extra refunded

## **Andover**

#### **Thefts & Damage to Property**

03.16~136xx Crosstown Blvd W  $-4^{th}$  degree DWI; a caller reported a possibly impaired driver. The deputy located the vehicle and stopped it for erratic driving. The driver appeared to be high on meth; acting agitated. Field sobriety tests were conducted and failed. The suspect complained of not feeling

well. An ambulance was called, and she was transported to the hospital. She will be arrested when released.

- 03.17 155xx Dakota St NW Assault, Obstruction; a deputy was called to a runaway who had assaulted staff. She was located and proceeded to try to bite the deputy when he was trying to help her. She was arrested.
- 03.17 14000 Block Aberdeen St NE Stolen Vehicle, Theft from Vehicles; the male who was seen trying to break into vehicles at the daycare fled deputies, stole a vehicle, abandoned the vehicle, and fled on foot. He was located. An ambulance was needed. He will be charged by formal complaint.
