FRIDAY UPDATE: 03.26.21

Here is a new scam that is being reported across the United States. We haven't seen any reports here, but we want to get the information out to you before this lands in your inbox. A bogus COVID vaccine survey.

People across the country are reporting getting emails and texts out of the blue, asking them to complete a limited-time survey about the Pfizer, Moderna, or AstraZeneca vaccine - and there may be one for Johnson & Johnson, too. In exchange for completing the survey, people are offered a free reward, but asked to pay shipping fees. If you get an email or text like this, **STOP**. It's a scam.

If you get an email or text you're not sure about:

- Don't click on any links or open attachments. Doing so could install harmful <u>malware</u> that steals your personal information without you realizing it.
- Don't call or use the number in the email or text. If you want to call the company that supposedly sent the message, look up its phone number online.
