FRIDAY UPDATE: 04.02.21

Here is a good reason to check your credit report regularly. This victim would never have found out about the identity theft if she hadn't. She was able to secure her accounts before it got too out of control.

I spoke with the victim by phone regarding an unknown person(s) opening an AT&T cell phone account in her name. She found the fraud occurred when she was reviewing her credit score. The victim said she found that an unknown person(s) opened an AT&T cell phone account in Detroit Michigan on March 1, 2020 and that account was opened with her social security number. The account continued until September 18, 2020 for a balance of \$623.29. The AT&T account then went to a collection agency, which has affected the victim's credit score. The victim wanted this activity documented with ACSO. No suspect information at this time.

Scams

03.30 Call claiming to be son, he was arrested and needed money – version of "grandparent" scam; loss \$9000 mailed to a "public defender" in Boston for "bail"

03.31 Call claiming to be Publisher Clearing House requesting CC# and \$500 to claim prize

04.01 Call from a Mexico prefix stating they had the victim's daughter and demanded ransom

Arrests

He was arrested and a friend was called to pick up the driver and child.

03.30~162xx Lexington Ave NE $-~2^{nd}$ degree DWI; a deputy was called to the location by a homeowner who explained a male was driving through her yard, snapping power line tethers, and hit her pole barn with his vehicle. When the deputy arrived and located the male, he appeared high. He was placed in an ambulance for care and field sobriety tests could not be conducted. A warrant for blood was obtained. Meth and other drugs were located in the vehicle. He was arrested when released from the hospital.

03.31 23xx 149 Ave NE – HRO Violation; a deputy responded to a male throwing an ax at a vehicle. The male in the vehicle had a restraining order against the male with the ax. After investigating, the male with the ax violated the restraining order and was arrested. Due to COVID restrictions right now in the jail, the suspect will be charged by citation.

04.01 134xx Hwy 65 NE — Domestic Assault; deputies responded to a call of "shots fired from a vehicle." The vehicle and occupants were located. Through investigation it was determined the male assaulted the female and he was arrested. A BB gun was located. While on the call, Juvenile Probations contacted deputies and asked us to arrest he female for a probations violation warrant.
