### Scam

04.09 A male reported he met a person playing on the app "words with friends" they started messaging privately and the male sent some nude photos. After the photos were sent the person began blackmailing him.

04.09 Computer hacked; a female then received a phone call requesting \$3000 dollars in Wal-mat gift cards.

04.10 Fake facebook friend request from someone claiming to be her Uncle. Stated he needed gift cards for a grant she could receive - \$3000 loss.

04.11 Phone call from someone in Las Vegas claiming he won 18 millions dollars and a new vehicle. No information was requested from the RP but was told he would receive a call back later tonight.

04.12 Ebay scam; male reported he made a purchase from a private seller and never received his purchase.

04.13 Text message claiming he owed for services he received and that if he didn't pay he "would be paid a visit"

04.14 Fake kidnapping scam; female received a call stating her daughter was kidnapped and that if she followed the instructions her daughter would be returned unharmed.
