**FRIDAY UPDATE: 04.23.21** 

Often times children forget who is in charge. I am glad we could assist.

On 04.21 a 16yo female called 911 because she was upset that her dad took her cell phone and threatened to break it. She said she paid for the phone and wanted it back. I told her that since she is 16 her Dad can do whatever he wants with her phone.

An attempt to locate was put out for a missing person from Oakdale. An observant store clerk noticed a confused male at a gas station in Columbus and was kind enough to call us to report it.

On 04/19/21, at 00:43 hours, I was dispatched to the Holiday gas station in Columbus on a report of an elderly male that appeared confused and disoriented. He had been in their parking lot for a couple of hours. The license plate of the car he was in listed to a male who had a KOPS alert out on him as a missing person out of Oakdale, MN. Upon arrival, I spoke with the male and confirmed his identity. I spoke with an Oakdale Officer and he made contact with the male's daughter. She requested her father be transported to the hospital. I obtained the keys to the vehicle and gave them to gas station staff; the daughter said they would pick up the vehicle later.

# **Scams/Fraud**

- 04.19 Call from Amazon claiming fraudulent charges on account asked for personal information
- 04.21 Phone call stating a "document" company needs info or the Sheriff will arrest him on a warrant
- 04.22 Victim went to file his taxes, and someone had already filed under his name and SS#
- 04.22 Call claiming to be SS office, threatened arrest if she didn't provide personal information

There was an uptick this week in reports of MN Unemployment Fraud from residents – 15 reports.

The driver appeared impaired but insisted he had nothing to drink. Field sobriety tests were conducted and failed. He was arrested. .203

04.17 141 Lane/Radisson Rd NE – Warrant Arrest; a deputy stopped a driver for speeding. When the driver was identified, it was learned he had warrants. He was arrested.
