**FRIDAY UPDATE: 04.30.21** 

This week's observation, if you have warrants don't live around attentive neighbors: Neighbors called in a possible burglary in progress. They observed a woman crawling in a back window and called 911. The deputies arrived and surrounded the home. When called out, a female came out of the home and identified herself. She stated she forgot her keys and therefore climbed through the window. She advised her roommate was supposed to be coming home to let her it, but he had not shown up yet. Once she was formally identified, it was learned she had three warrants. She was arrested.

#### Scams

04.24 Amazon scam, received item that wasn't right, googled number on how to return it, allowed remote access to Venmo account, fake Amazon person stole \$300 from the account

04.27 Phone call claiming to be SS office; demanded personal info or they would issue a warrant

04.28 Phone call claiming to be SS office; demanding personal info

04.29 Call claiming to be Publishers Clearing house stating she won a truck, requesting gift cards
