# FRIDAY UPDATE: 05.21.21

If this happens to you, we hope that you would also call and report the suspicious activity when it is happening:

I was dispatched a phone call and asked to call regarding suspicious activity that occurred at her house last night. She reported that last night around 1900, three males drove onto her property in a dark sedan. She said that one of the males asked her about her selling a snowmobile, which she had no knowledge of. She described the males as three late teens or early 20's white males. She was concerned due to recent thefts and burglaries in the area and wished for deputies to provide extra patrol. I told her I would document what she told me and submit a request for extra patrol.

He observed the driver did matched the description of the registered owner and stopped the vehicle. When the deputy approached the vehicle, he smelt alcohol and marijuana. Field sobriety tests were conducted and failed. The vehicle was searched, and meth and marijuana were found. The PBT showed .00 so a warrant for blood was received and he was arrested. Charges were elevated due to three prior DWI's, no license, and drugs.

05.18 16xx 155 Ave NW – Warrant Arrest; a deputy learned of a female at the location who had a warrant. She was located and arrested.

### Arrests
