FRIDAY UPDATE: 07.09.21

Last week we were called to a home where people passing by heard a male yelling for help. When deputies arrived, they saw a male laying on the floor and were able to force their way into the home. The male had fallen and could not get up; he stated he had been laying there for three to four days.

There are many people who don't have anyone who would notice if they haven't been around for a few days. I would like to suggest, even if you are not close or even neighborly, if you have a person living in your neighborhood that doesn't get a lot of company, or have any family in the area, that you just check-in on them regularly. This seems like it would be so easy and could really make a person feel valued, and possibly save their life.

Scams

07.02 Victim received a phone call from someone claiming to be from Wells Fargo fraud department stating there was suspicious activity on his account. The victim had a Wells Fargo account. To "reverse" the fraud amounts, the victim was sent a text with a code that he needed to provide to the fraud department and the charges would be reversed. It was scammers; \$35K was stolen from the account.

07.06 Phone call claiming to be a "law enforcement official" investigating drug crimes and stated the victim is a suspect and began asking the victim for his personal information.

07.07 Phone call claiming to be from "Amazon Security Fraud" department; they stated the victim's account may have been hacked and an IPhone was ordered. Asked for credit card information.

07.08 Phone call claiming to be from the Sheriff's Office stating we were attempting to collect debt from him and he would be arrested if he did not comply.
