FRIDAY UPDATE: 07.23.21

This was a funny report I read this week and wanted to share. I haven't seen this before.

A neighbor called to report that she heard a female yelling and someone saying, "put your hands up." We arrived and found a male playing Grand Theft Auto on his computer.

Scams

07.16 Victim was scammed by someone posing as a representative from Direct TV and AT&T calling from 855-673-0203. They told her they could lower her bill. Ironically, she had spoken to Direct TV 3-4 weeks earlier and was able to lower her bill by \$13 so she was excited to lower it more. They told her they would enroll her in the loyalty program to lower her bill. They told her to purchase Apple gift cards and they would refund the difference. In the end, she had purchased \$2,100 in Apple Gift Cards and sent pictures of them to the representative. The rep's name was Edward Green at 609-761-2888 and was also the same number she texted the pictures of the cards to. When she questioned Green, she was sent to a Mark Buttener at 609-269-4252. She stopped sending anything when they kept telling her she was sending the wrong amount.

07.16 A victim stated that AT&T advised her to call a number to get a TV added to her plan. She said when she called the number a male said she would need to get 2 \$200.00 gift cards to update her account and pay her bill. She said she got the cards and gave the male the number on the back of them. The number she called was 833-823-0050 and she was speaking to Brian Davis.

07.19 The victim stated he received a phone call from an unknown number. The caller stated they were from the IRS and he had a warrant out for his arrest. They also told him that he needed to take money out of his bank account. The phone call was then transferred to another person. The victim became suspicious. He did not provide them with any personal information.

07.20 A caller reported a suspicious phone call. He stated he received a call from someone claiming to be a Public Defender who had been assigned his son Todd's case. The Public Defender stated that Todd was in jail for endangering someone during an accident and it was going to cost \$95,000 bail or \$9,500 bond to get Todd out of jail by contacting Carlos Ortiz. The victim recognized that the phone call was a scam and didn't provide the caller with any information. The call came from Woodbine, NY.

07.21 Victim responded to an online request to be a "Mystery Shopper." She received a check for \$2250 and was told to cash it. The suspect instructed her to buy \$1850 in gift cards and that she could keep the left-over money as payment. The check was fake and the victim's bank account was debited the original check amount, and she was out the \$1850 in gift cards she purchased.

07.21 Victim was contacted by phone by the "US Custom Border Protection Agency" who told him he is being investigated for drug smuggling and money laundering. The person asked for the local law

enforcement agency's number and he gave it to them. The victim then received a call from a male who stated he was "Officer Stuart" with the Anoka County Sheriff's Office and instructed him to place money in a Crypto Currency account. The victim hung up because he knew "officer" Stuart was really Sheriff Stuart.

07.21 Victim was sending Snaps and Insta photos to an unknown female. After inappropriate photos were exchanged, the unknown female blackmailed the victim for \$1000 otherwise she would leak the photos on his social media accounts.

07.19 Bunker/Goldenrod St NW – Warrant; a deputy stopped a vehicle for poor driving conduct. The driver was identified, and she didn't have a driver's license – she was issued a citation. The passenger was identified, and he had a warrant – he was arrested.

07.22 136xx Quinn St NW – Domestic; deputies were called to a business because of a domestic occurring between a husband and wife. The husband was arrested.
