### **Scams**

10.31 Snap Chat: The victim stated that today he was communicating with an unknown female on Snap Chat. This female requested nude photos and videos of the victim. He provided these images to this female. He was then informed by this female that he needed to pay her so the images would not be disseminated to his friends. This female requested \$1,000 dollars in gift cards. The victim went to Walmart and purchased \$650 dollars' worth of gift cards and provided the information to this female. It was not one thousand dollars as requested so this unknown female sent the images to some of his old friends on Instagram. This female requested the rest of the payment by Friday or all of his friends on Instagram would receive the images.
