FRIDAY UPDATE: 12.16.22

Scams

12.09 The victim stated she received a text message at 1440 hours from phone number (1) 470-796-4334. The message stated it was from her friend requesting a transfer of money for business-related expenses. The victim ultimately initiated a transfer of \$728.00 via Venmo and the person then requested an additional \$1,172.00. At that point, the victim became suspicious and refused to send the additional money. She realized that the messages were not actually coming from her friend, and she stopped responding to the individual. She stated she had already contacted her bank as well as Venmo regarding the incident.

12.15 The victim told me he was being blackmailed. He explained that someone who was communicating with him had gotten nude pictures of him. He said that a person posing to be a female started messaging him through Facebook and they exchanged cell phone numbers; he started communicating with this person in June of 2021. The person he was talking to eventually threatened to share the nude pictures of him if he did not pay them. He said he had already given \$1,000 to the blackmail scam via PayPal. The username paid was 'ELJONMALABANAL'. He decided to stop contacting the scammer. The scammer eventually was able to find his girlfriend and sent her a picture of him nude and demanded more money or else the scammer threatened to share the picture with his friends and family. The victim was wondering if there was a way I could stop the blackmail. I informed him that I did not have the power to stop the blackmail myself. I advised him to stop communicating with the scammer and not to send them more money because this will not stop them.

12.10 22xx Bunker Lake Blvd NW – a secured bike was stolen from the bike rack outside of Festival

12.12 34xx Bunker Lake Blvd NW – Warrant Arrest; a deputy observed a female pulling into a parking lot and he knew she had a warrant. He followed her and made contact. She was arrested.

12.12 137xx Round Lake Blvd NW – Warrant Arrest; a deputy went to the location to look for a male with a warrant. When he arrived, the owner let him look around the business. The suspect had locked himself in the freezer. A key was obtained, and the male was arrested.

The driver was stopped and immediately started fighting with the deputies. He was eventually handcuffed. One of the field sobriety tests were conducted and failed. He was arrested. .19 Charges were elevated due to two prior DWI's.

12.13 136xx Martin St NW – Warrant Arrest; Brooklyn Park Police asked us to go to the location and locate a male who had a warrant. Deputies arrived and located the man, and he was arrested.

12.14 7xx 143 Ave NW – Agency Assist, HRO Violation; Ramsey Police asked us to go to the location to see if a male was there who had violated a restraining order in their city. The male was there, he was arrested and turned over to Ramsey PD.

The male refused to roll down the window stating COVID concerns; the deputy still smelled alcohol and the driver appeared impaired. The driver stated he had 4 – 5 beers. Field Sobriety tests were conducted and failed. The driver refused to provide a breath sample. He was arrested. .19

Deputies arrived and made contact with the occupants, and they were doing drugs. They were identified and the female had multiple warrants. She was arrested. While searching her and the vehicle, meth and fentanyl were found.

12.10 Bunker Lake/Radisson Rd NE – Warrant Arrest; a deputy ran a plate and the registered owner came back with warrants and no driver's license. He stopped the vehicle and identified the driver. He was arrested.

12.10 162xx Lexington Ave NE – Warrant Arrest; a caller reported a male banging on his front door and deputies responded. The caller called back and stated he did not need help because it was a friend. Well, the friend had a warrant. Deputies arrested the male.

12.12 Constance/Hwy 65 NE – Warrant Arrest; a deputy observed a female in a vehicle and knew she had a warrant. He stopped the vehicle, and the woman was arrested. The male driver was acting suspiciously and while deputies were talking to him, he became agitated and began fighting with deputies. The male also had a warrant. Both went to jail.
