**FRIDAY UPDATE: 12.23.22**

### **Scams**

12.19 Victim stated that on 12/17 she was contacted via Facebook from someone who said that they wanted to give away a PlayStation 5. She messaged them about the item. The account messaged her and stated that they did not have enough money to pay for shipping and that she had to send \$61 via PayPal. She said she did this but then they messaged again and said they needed \$70 more for shipping costs. The victim sent that money but became suspicious. She stated that she contacted PayPal to cancel the money being sent. Someone at "PayPal" routed her to another person who made her download an app on her phone so they could help fix this. She said she did download the app but after, her phone started to act odd and she hung up on the person and deleted the app. After this she said that she was getting notifications that her bank account had been locked along with her PayPal.

12.21 The victim reported being called by someone posing as Publishers Clearing house and saying she won but they needed \$640 to clear the taxes in the form of a Walmart gift card. She did not get the gift card hung up on them. They called from 870-724-5609. I called the number and received a message the number is not in service.

12.22 This is new. The victim stated that on 12/20 he had received messages on Instagram from a female who stated that she wanted to use his photos in artwork. The victim agreed. As compensation, the user offered to pay him \$3,000 once the "piece" was completed. A short time later, the female asked him for his email and other contact information along with what branch of bank he used. He informed her that he used US Bank but did not provide any other identifying information to any of his accounts. The victim received an electronic check for \$3,000 that he deposited it to his account via his phone. The female then asked him to send her back \$2,500 for costs of the supplies and services. He became suspicious at this time and reported the activity to his bank. The bank cleared the \$3,000 check and he is not out any money, nor did he believe any of his other information had been compromised. He was advised to change his passwords.

He was allowed to call a friend to drive his vehicle home instead of having it towed. However, the female in the passenger seat had multiple warrants and she was arrested.

He was issued a citation and allowed to drive the vehicle a block to get home. However, the passenger had a warrant. When the deputy told him he was under arrest, the male began fighting and he had a knife on him. Back-up was called and the male was arrested.

12.21 Viking/Nightingale St NW – DWI; a deputy observed a vehicle in the ditch and stopped to help. When she looked in the vehicle, it was empty. While on scene, a male in van returned but when he saw deputies, he ran. He was caught and appeared impaired. After investigating, this male was the driver. Field sobriety tests were refused but the male PBT'd .14. He was arrested.
