Subject:	2023 Street Maintenance Program bids

Introduction:

The City of Ham Lake has entered into a Joint Powers Agreement with fifteen other local cities to form the North Metro Regional Street Materials Regional Group. The group of cities has a Joint Powers Agreement to combine certain bid items to reduce the number of contracts needed and hopefully achieve lower bids from contractors.

Discussion:

The results of the March 17th bid opening for the 2023 street maintenance are attached. The bid results and recommendation has been discussed with Superintendent John Witkowski.

Allied Blacktop is the low bidder for FA-1 1/8" seal coat aggregate and CRS-2P seal coat oil, with a bid of \$1.38 per square yard and \$1.75 per gallon respectively. The bid amounts to \$61,888.86 for the 44,847 square yards of seal coat aggregate and \$21,190.75 for the 12,109 gallons of polymer seal coat oil for a total of \$83,079.61. The total seal cost low bid is 5.58% over the estimated cost \$78,685.10.

Warning Lites is the low bidder for latex paint markings, parking lot markings and symbols, with bids of \$27.73, \$101.60 and \$101.60 per gallon respectively. The 1,200 gallons is enough paint to re-stripe the existing striped MSA streets centerline, turn lanes and fog lines, the 12 gallons is enough to stripe the City Hall, Fire Station #1, Senior Center and Tennis Court parking lots and the 20 gallons is enough paint for stop lines, single arrows, double arrows and crosswalks. The bid amounts to \$36,527.20. The striping low bid is 9.94% under the estimated cost of \$40,560.00.

Allied Blacktop Company is the low bidder for crack sealing, with a "route and seal" bid of \$0.56 per lineal foot. For the 41,315 lineal foot quantity, the bid amounts to \$23,136.4. The crack sealing low bid is 9.68% under the estimated cost of \$25,615.3.

The total of the three low bids is \$142,734.21. This is 1.46% under the total estimated cost of \$144,860.40.

Recommendation:

It is recommended that the City concur by motion to award to the low bidders for seal coating, striping/symbols and crack sealing to Allied Blacktop Company, Warning Lites and Allied Blacktop Company respectively.

Subject: Approval of the American Rescue Plan Act Funding for Public Works Equipment

Introduction/Discussion:

In March of 2021, the U.S. Congress adopted the American Rescue Plan Act (ARPA). The State of Minnesota received approximately \$377 million to allocate out to its jurisdictions with a population below 50,000. In July 2021, the City requested their \$1.776 million allotment and then was notified in December of 2021 an additional \$58,156.72 of unused funds would be distributed bringing the total amount of ARPA funds to approximately \$1.834 million. The funds can be used for costs after March 3, 2021 and must be obligated to an item by December 31, 2024 and distributed by December 31, 2026.

During the March 21, 2022 Council meeting, a resolution was passed determining the City would be using the Revenue Replacement option to expend the funds. The Revenue Replacement option has a standard allowance of \$10M or less to be used for what the City deems necessary.

As of March 29, 2023 there was approximately \$121,188 of unallocated ARPA funds for use. There currently has been \$558,771 expended from the ARPA funds with \$1.1M earmarked for the Revolving Street Fund and another \$54,124 earmarked for approved Public Works Department Expenditures and Sirens.

Public Works is requesting to use an additional \$2,100 of the funding for a Dell Rugged Laptop with docking station in order to run their new vehicle scanning software to help track vehicle maintenance.

The approval of these items would bring the amount of unallocated ARPA funds to \$119,089.

Recommendation:

Approval of the Resolution to allocate \$2,100 of ARPA funding for a Dell Rugged Laptop with docking station.
